 (c) not register a financing change statement in respect of a security interest without the prior written consent of the Contractor;

 (d) not register, or permit to be registered, a financing statement or a financing change statement in relation to the Goods in favour of a third party without the prior written consent of the Contractor and read read read in the statement of the Contractor of any material change in its business practices of selling the Goods which would result in a change in the nature of proceeds derived from such sales.

 (a) where the Client and/or the Guarantor (if any) is the owner of land, realty or any other asset capable of being charged, both the Client and/or the Guarantor agree to mortgage and/or charge all of their joint and/or several interest in the said land, realty or any other asset to the Contractor or the Contractor's nominee to secure all amounts and other monetary obligations payable under these terms and conditions. The Client and/or the Guarantor acknowledge and agree that the Contractor (or the Contractor's nominee) shall be entitled to lodge where appropriate a caveaut, which caveat shall be withdrawn once all payments and other monetary obligations payable hereunder have been met. hereunder have been met.

Defects

 The Client shall inspect the Goods on delivery and shall within three (3) days of delivery (time being of the essence) notify the Contractor of any alleged defect, shortage in quantity, damage or failure to comply with the description or quote. The Client shall afford the Contractor an opportunity to inspect the Goods within a reasonable time following delivery if the Client believes the Goods are defective in any way. If the Client shall fail to comply with these provisions the Goods shall be presumed to be free from any defect or damage. For defective Goods, which the Contractor has agreed in writing that the Client is entitled to reject, the Contractor's liability is limited to either (at the Contractor's discretion) replacing the Goods or repairing the Goods except where the Client has acquired Goods as a consumer within the meaning of the Competition and Consumer Act 2010 (CWIth) or the Fair Trading Acts of the relevant state or territories of Australia, and is therefore also entitled to, at the consumer's discretion either a refund of the purchase price of the Goods, or repair of the Goods.

The Contractor shall not be bound by nor be responsible for any term, contidion, representation or warranty other than that which is given by the manufacturer of the Goods.

 The conditions applicable to the warranty given on Goods supplied by the Contractor are contained on the "Warranty Card" that will be supplied with the Goods.

- Intellectual Property
 Where the Contractor has designed, drawn or written Goods for the Client, then the copyright in those designs and drawings and documents shall remain vested in the Contractor, and shall only be used by the Client at the Contractor's discretion. The Client warrants that all designs or instructions to the Contractor will not cause the
- Contractor to infringe any patent, registered design or trademark in the execution of the Client's order and the Client agrees to indemnify the Contractor against any action taken by a third party against the Contractor in respect of any such infringement.

The Client agrees that the Contractor may use any documents, designs, drawings or Goods created by the Contractor for the purposes of advertising, marketing, or entry into any competitio

Default and Consequences of Default

- Default and Consequences of Default Interest on overdue invoices shall accrue daily from the date when payment becomes due, until the date of payment, at a rate of two and a half percent (2.5%) per calendar month (and at the Contractor's sole discretion such interest shall compound monthly at such a rate) after as well as before any judgment. In the event that the Client's payment is dishonoured for any reason the Client shall be liable for any dishonour fees incurred by the Contractor. If the Client defaults in payment of any invoice when due, the Client shall indemnify the Contractor from and against all costs and disbursements incurred by the Contractor in pursuing the debt including legal costs on a solicitor and own client basis and the Contractor's collection agency costs. Without prejudice to any other remedies the Contractor may have, if at any time the Client is in breach of any obligation (including those relating to payment) the Contractor musped or terminate the supply of Goods to the Client any of its other obligations under the terms and conditions. The Contractor will not be liable to the Client for any loss or damage the Client suffers because the Contractor has exercised its rights under this clause.

- Cancellation

 The Contractor may cancel any contract to which these terms and conditions apply or cancel delivery of Goods at any time before the Goods are delivered by giving writen notice to the Client. On giving such notice the Contractor shall repay to the Client any sums paid in respect of the Price. The Contractor shall not be liable for any loss or damage whatsoever arising from such cancellation.

 In the event that the Client cancels delivery of Goods the Client shall be liable for any loss or incurred by the Contractor (including, but not limited to, any loss of profits) up to the time of cancellation.

 The Client understands that the information exchanged can include anything about the Client's creditworthiness, credit standing, credit history or credit capacity that credit providers are allowed to exchange under the Privacy Act 1988.

 17.3 The Client consents to the Contractor being given a consumer credit report to collect overdue payment on commercial credit (Section 18K(1)h) Privacy Act 1988.

 17.4 The Client agrees that personal credit information browded may be used and retained by the Contractor for the following purposes (and for other purposes as shall be agreed between the Client and Contractor or required by law from time to time):

 (a) the provision of Goods by the Contractor, its agents or distributors; and/or (c) analysing, verifying and/or checking the Client's credit, payment and/or status in relation to the provision of Goods, and/or

 (e) enabling the daily operation of Client account and/or the collection of amounts outstanding in the Client's account in relation to the Goods.

 17.5 The Contractor may give information about the Client of a credit reporting age

- following purposes:

 (a) to obtain a consumer credit report about the Client;

- tollowing purposes:

 (a) to obtain a consumer credit report about the Client;

 (b) allow the credit reporting agency to create or maintain a credit information file containing information about the Client.

 The information given to the credit reporting agency may include:

 (a) personal particulars (the Client's anea, sex, address, previous addresses, date of birth, name of employer and driver's licence number;

 (b) details concerning the Client's application for credit or commercial credit and the amount requested;

 (c) advice that the Contractor is a current credit provider to the Client;

 (d) advice of any overdue accounts, loan repayments, and/or any outstanding monies owing which are overdue by more than sixty (60) days, and for which debt collection action has been started;

 (e) that the Client's overdue accounts, loan repayments and/or any outstanding monies are no longer overdue in respect of any default that has been listed;

 (f) information that, in the opinion of the Contractor, the Client has committed a serious credit infingement (that is, fraudulently or shown an intention not to comply with the Clients credit obligations);

 (g) advice that cheques drawn by the Client for one hundred dollars (\$100) or more, have been dishonoured more than once;

 (h) that credit provided to the Client by the Contractor has been paid or otherwise discharged.

- Building and Construction Industry Security of Payments Act 1999
 At the Contractor's sole discretion, if there are any disputes or claims for unpaid Goods

 The Client agrees that the Contractor may review these terms and conditions, then that change will take effect from the date on which the Contractor notifies the Client of such change. The Client shall be under no obligation to accept such changes except where the Contractor supplies further Goods to the Client and the Client accepts such Goods.
